No amendment shall change any condominium parcel or a condominium unit's proportionate share of the common expenses or common surplus, nor the voting rights appurtenant to any unit, unless all record owner(s) thereof, and all record owners of mortgages or other voluntarily placed liens thereon, shall join in the execution of the amendment.

b. If the proposed change has not been approved by the unanimous vote of the full Board of Directors, then the proposed changes must be approved by two-thirds (2/3) vote of the membership which would be 274 votes.

All amendments shall be recorded and certified as required by the Condominium Act. No amendment shall change any condominium parcel or a condominium unit's proportionate share of the common expenses or common surplus, nor the voting rights appurtenant to any unit, unless all record owner(s) thereof, and all record owners of mortgages or other voluntarily placed liens thereon, shall join in the execution of the amendment. No amendment shall be passed which shall impair or prejudice the rights of any lessor's interest under any lease.
