To sign up for the Lot 9 parking and Marina Wet Slip lottery, please fill out and fax, mail, or email all the appropriate forms listed below to the above address.

All documentation must be received no later than 5pm on September 29th, 2023. If any of the documents are missing or incomplete, you will not be entered in the drawing.

# **Lottery Procedures**

- 1. Attendance is not required.
- 2. Priority will be given to owners in both lotteries. If spaces are still available after the lottery, a second drawing will be held for renters.
- 3. Priority for Marina Wet Slips will be given to dry lot owners. However, if an owner has multiple dry lots, then all the owner's lots will be entered in the drawing. Once one of the lots has been awarded a slip, the remaining lot numbers will be removed from the drawing.
- 4. Once all the proper paperwork is received the corresponding lot will be entered in the drawing.
- **5.** Each approved entry will be assigned a corresponding numbered ball which will be randomly drawn lottery style at an open meeting.
- 6. Management will assign Marina Wet Slip and Lot 9 Trailer parking numbers then notify all lottery winners.
- 7. Once all Marina Wet Slips and Lot 9 Trailer spaces have been assigned and there are no owners on the waiting list, renters may rent empty Marina Wet Slips and/or Lot 9 Trailer spaces at a rate of \$100 per month for the Marina and \$30 per month for Lot 9.
- 8. If a unit is rented during the lease period owners are not permitted to participate.

# Sharing Wet Slips Procedures

- 1. Owner's MUST declare the sharing of the slip BEFORE the drawing.
- 2. Once the first name is drawn, the second name (if drawn) is not valid.
- 3. The two (2) lot owners agree to share one (1) spot for ONLY their registered vessels.
- 4. The park does not get involved or mediate for the two (2) lot owners. The park will recognize one as the primary which will be held responsible in any discrepancy.
- 5. Both registered vessels must fit in the awarded slip.



Rent, in the full amount of \$576, for the Marina and/or \$130 for Lot 9 will be paid prior to the beginning of the term of this six-month non-renewable Agreement.

ORLK is NOT responsible for any loss or damages that may occur to lessee's boat, trailer, or personal property. The lessee agrees to hold ORLK harmless and to indemnify ORLK against any public liability and/or property damage liability which may arise by reason of lessee's use of the Marina and/or Lot 9, including attorney fees and costs incurred in defending any claims. Lessee agrees to assume all responsibility for insuring lessee's trailer, if parked in Lot 9 and to assert no claim of coverage under any policy of ORLK for claims arising out of such use. If assigned a slip in the ORLK Marina, the lessee's boat must be covered by liability insurance providing a minimum of \$100,000 single limit coverage. A copy of lessee's insurance declaration page must be furnished to ORLK prior to the beginning of the term of this Agreement.

Lessee agrees, by signing below, to have read and understand ORLK Rules and Regulations concerning the use of lessee's assigned slip in the Marina and/or the use of Lot 9 and agrees to abide by the terms and conditions set forth in the subject Rules and Regulations.
